II. Purposes for Processing Your Personal Data and How It Is Collected;

When you visit the website <u>https://www.idex.org.tr/</u>, express interest in participating in the IDEX fair, or make any related inquiries, the personal data you provide will be processed in a manner that is consistent with the purposes mentioned below, in accordance with the KVKK Legislation. Your data will be processed in a limited and measured manner through both electronic and physical means, using automatic and non-automatic methods.

I. Methods of Collection and Legal Grounds for Processing Your Personal Data

Your personal data, which we collect through your visit to the website <u>https://www.idex.org.tr/</u>, your communication through the website for organizing

online invitations, inquiries, participation, sponsorship, or by completing relevant forms, will be processed by DİŞSİAD CONGRESS for the following legal grounds:

- Based on your explicit consent, we process your data to communicate with you for the purposes outlined above, provide information, respond to your requests and inquiries.
- Based on your explicit consent, we may contact you to inform you about our campaigns related to DİŞSİAD CONGRESS fairs and other events, and to measure your satisfaction with our activities and events.
- When processing personal data is necessary to establish or perform a contract, including agreements related to fair participation or advertising and sponsorship.
- Based on our legitimate commercial and financial interests, we process personal data to ensure the security of the fairgrounds, participants, and visitors, to conduct our fair organization activities, to plan the fairgrounds and events, and to ensure that participants and visitors benefit maximally from the fair and their expectations are met. This data processing is necessary for analyzing visitor and participant profiles at the fair.
- Based on our legitimate commercial interests, we process personal data to carry out the promotion and marketing activities of the IDEX fair, provided that it does not infringe on your fundamental rights and freedoms.
- To fulfill our legal obligations in the areas of taxation, finance, and accounting.
- As explicitly required by laws such as Law No. 5651, the Turkish Commercial Code No. 6102, Law No. 6563, and tax legislation.
- When required by judicial or administrative authorities, in case of any dispute or legal obligation, personal data processing is necessary to establish, exercise, or defend legal rights.

If you provide explicit consent to communicate with us via WhatsApp, we will process your name, surname, phone number, and the content of your messages to respond to your inquiries. The details regarding data processed and transferred through WhatsApp can be found in the "Clarification Text on Personal Data Processed and Transferred via WhatsApp Communication Line."

II. Sharing Your Personal Data with Third Parties and for What Purposes

As per the KVKK legislation, unless otherwise stated, your personal data is shared with third parties for limited and related purposes and is processed and protected under a contractual relationship that requires the third party to comply with data protection obligations. These third parties are under DİŞSİAD CONGRESS's supervision.

Your personal data may be shared with public institutions, judicial authorities, regulatory bodies, and other relevant authorities to fulfill our legal obligations. It may also be shared with our service providers and other third parties (such as IT specialists, database providers, backup and recovery experts, fair organizers, etc.) to carry out DİŞSİAD CONGRESS's business activities, under the terms of the KVKK legislation.

III. Protection of Your Personal Data

DİŞSİAD CONGRESS is obligated to prevent unlawful processing of personal data, unauthorized access to personal data, and ensure the proper storage of personal data. To fulfill

these obligations, we take all necessary technical and administrative measures to ensure an appropriate level of security for the protection of your personal data.

IV. Your Rights and How to Exercise Them

As per the KVKK legislation, you have the following rights and can request to exercise them by applying to DİŞSİAD CONGRESS:

- 1. To learn whether your personal data is being processed,
- 2. If your personal data has been processed, to request information about it,
- 3. To learn the purpose of processing your personal data and whether it is being used in accordance with the intended purpose,
- 4. To know the third parties to whom your personal data has been transferred, both domestically and internationally,
- 5. To request the correction of incomplete or inaccurate data, and in accordance with legal requirements, request the deletion or destruction of your personal data, and to request the notification of this correction or deletion to third parties to whom the data has been transferred,
- 6. To object to the processing of your data exclusively through automated systems, which may result in a decision that negatively affects you,
- 7. To request compensation for any damages caused by the unlawful processing of your personal data.

You may submit your request to DİŞSİAD CONGRESS in writing, with a wet signature, or via a registered electronic mail (KEP), secure electronic signature, or mobile signature, or the email address previously registered with DİŞSİAD CONGRESS.

DİŞSİAD CONGRESS will respond to your requests in the shortest time possible, and no later than thirty (30) days, free of charge. However, if the request requires additional costs, a fee may be charged as per the tariff set by the Personal Data Protection Authority.
